#### POST GRADUATE PROGRAMME IN SOCIOLOGY

The Post Graduation (PG) programme in Sociology offered by the Department of Sociology, School of Liberal Studies, at KIIT Deemed to be University is a dynamic and forward-looking postgraduate programme designed in accordance with the National Education Policy (NEP) 2020. It is designed to foster advanced knowledge in cutting- edge areas of sociological theories and methodologies. This programme aims to equip students with the expertise to apply sociological principles to real-world problems, facilitating in-depth analysis and insightful solutions. The education system in the emerging scenario demands enriching the students to develop a holistic personality. Therefore, the focus is based on the four pillars of education which are learning to know, learning to do, learning to live together, and learning to be.

With a curriculum design that reflects the best and updated Sociology papers and practice, the objective of the programme is to impart sociological education with an employability outlook. With an eclectic mix of courses viz., stratification, inequality & society, digital sociology, statistical sociology, war, peace & conflict studies, sociology of food, law, crime & criminal justice, sociology of entrepreneurship and many more, the programme promises to be an enriching amalgam of core and interdisciplinary courses. For a student of sociology, field exposure is primary. The courses viz. Looking Beyond Classroom and provisions for Capstone project will ensure students' understanding of theories and approaches is applied in practice. The programme is an outcome of the ever-evolving market situation and socio-political and cultural changes that we observe around us. The focus is to prepare students as future-ready, i.e., to become social entrepreneurs, administrators, social science analysts, media personnel, academicians, researchers, social workers in voluntary sector and international organizations viz., the United Nations, World Health Organization etc or senior level executives in the private and public sector industries or pursue higher education, by equipping students with a holistic view of the sociological environment and its operations. The thrust of the programme is on personality development of the students by helping them acquire conceptual, analytical, problem-solving capabilities and emotional maturity. The innovative curriculum and proven pedagogy will equip students with actionable knowledge and skills along with deep insights into leadership, management and strategy.

The programme's teaching methodology and approach are designed to leverage technology and maximize interaction seamlessly and simultaneously. The programme follows a pedagogy that is a blend of Lectures, Field Studies, Case Studies, discussions and dialogues, Seminars, documentaries, Projects, Assignments and term papers, Class Presentations, Quizzes, etc.

The PG programme in Sociology at KIIT DU, as per National Education Policy-2020 (NEP- 2020) currently consists of the 2-year programme, with the second year primarily dedicated to research, for any graduates of 3-year Bachelor's programs. Alternatively, for those completing the 4-year Bachelor's any programme with Honours/Honours with Research would be considered for a 1-year Master's programme.

#### PROGRAMME OUTCOMES (POs)

By the end of this programme, a student will be able to:

- 1) Develop a sociological imagination to understand and analyse the sociological theories that explain complexities and changes of socio-political and economic mechanisms of societies and cultures
- 2) Demonstrate critical thinking and innovative mindset while engaging with interdisciplinary areas viz., statistical sociology, digital sociology, sustainability, sociology of food, law, crime and criminal justice, modernity, technology and kinship and many more.
- 3) Design and conduct original research projects by applying appropriate research methodologies and theoretical frameworks in sociological and cultural studies.
- 4) Employ a wide range of sociological thought, from classical to modern and contemporary, in the interpretation of social changes, cultural phenomena, sociological texts and research findings.
- 5) Analyse sociological texts in both local and global contexts, engaging with diverse sociological traditions and appreciating differences in terms of social milieu, cultural gaps and technological lags.
- 6) Utilize digital tools and media platforms to explore, analyze, and produce scholarly and creative content within the field of courses related to cultural studies, stratification and inequalities and digital sociology.
- 7) Communicate effectively in academic and professional settings by writing, editing, and producing coherent, well-structured arguments and creative outputs.
- 8) Critically engage with issues of marginalization, inequities, power, identity, gender, sexuality, caste, race, institutions, culture and technology and environment not only in sociological and cultural studies texts but also on the field.
- 9) Manifest the skills gained in professional domains viz. administration, social entrepreneurship, media and journalism, content creation, voluntary sectors and other international organisations, MNCs, academics, research-based organizations and think tanks.
- 10) Pursue lifelong learning through sustained intellectual curiosity, interdisciplinary inquiry, and adaptability to new knowledge systems and socio-cultural paradigms.

#### PROGRAMME SPECIFIC OBJECTIVES (PSOs)

- 1) Enable students to engage with sociological concepts and theories by critically analyzing the evolution of sociological thought from classical, modern to the contemporary period.
- 2) Foster the ability to apply diverse theoretical and critical frameworks—including structural functionalism, interpretative analysis, structuralism, Marxism, phenomenology, hermeneutics, feminism, post structuralism, post colonialism, social ecology and post modernism—in the interpretation of texts, socio-political and economic events, social and cultural issues.
- 3) Strengthen competency in sociological methods (both qualitative and quantitative), techniques and tools of research and the use of latest software for data analysis.
- 4) Prepare students to produce original research outputs through the application of research methodologies, critical inquiry, and academic writing, culminating in dissertations, projects, seminars, documentaries and scholarly presentations.

- 5) Promote an understanding of local, regional, national, and global literary traditions with sensitivity to questions of identity, caste, religion, ethnicity, language, class, gender, culture and nationhood.
- 6) Equip students to demonstrate expertise in thematic and interdisciplinary areas such as science, technology and society, cultural studies, gender, sexuality and intimacy, technology and kinship, statistics and sociology, law and criminal justice, sociology of entrepreneurship, social ecology etc.
- 7) Develop students' proficiency in digital, technological and statistical tools for sociological and interdisciplinary data analysis, research and report writing with emphasis on digital sociology, statistical sociology and science technology and society.
- 8) Encourage and train students for field engagements through course specific and programme specific field work, internship with NGOs and publication and media houses.
- 9) Promote socially engaged scholarship, values and critical citizenship by enabling students to interrogate and challenge structures of power and exclusion through nuanced engagements with issues of caste, gender, race, class, and environmental justice.

#### PROGRAMME EDUCATIONAL OBJECTIVES (PEOs)

The Programme Educational Objectives are to:

- 1) Prepare students to pursue advanced academic and professional careers in the fields of sociology, cultural studies, education, social work, administration, journalism and media, voluntary sector, research, content development, creative industries and allied fields.
- 2) Enable graduates to contribute meaningfully to sociological and cultural discourses through critical scholarship, field engagements, and participation in inter-disciplinary and cross-cultural debates and dialogues.
- 3) Foster lifelong intellectual growth and adaptability by cultivating a habit of critical inquiry, continuous learning, and openness to new knowledge systems, technologies, and sociocultural perspectives.
- 4) Encourage socially responsible and ethical citizenship by equipping graduates with the sensitivity to engage with issues of social justice, equity, diversity, and sustainability in both local and global contexts.

#### **Curricular Components at Entry Level for a Post Graduate Programme:**

- ❖ 1-year PG Diploma in Sociology: Students exiting after 1-year of 2-year of PG with a minimum credit earned equivalent to 40 will be awarded with PG Diploma in Sociology.
- ❖ 1-year Master of Arts in Sociology: Students entering 1-year Master of Arts in Sociology after completion of 4-year UG programme (with a minimum of 160credits) can choose to do (i) only coursework or (ii) only research or (iii) coursework and research.
- ❖ 2-year Master of Arts in Sociology: Students entering 2-year Master of Arts in Sociology after a 3-year UG programme (with a minimum of 120 credits) can choose to do (i) only course work in the third and fourth semester or (ii) course work and research in the third semester and fourth semester or (iii) only research in the third and fourth semester.

The programme is intended to sharpen the students' analytical abilities to optimally solve problems, the curriculum, in general, comprises advanced skills and real-world experience and less of a research component

#### **Exit Point of programme:**

- ➤ In case of PG in Sociology (1 Year) programme, there shall be no exit point. All enrolled students have to complete their post-graduation within 1-year duration/two semesters.
- In case of PG in Sociology (2Year) programme, there shall only be one exit point for those who join two-year PG programme. However, students who exit at the end of 1st year shall be awarded a Postgraduate Diploma in Sociology and they shall have to complete their PG within the duration of 4 years.
